

# Be efficient with your taxes.

Planned Giving tools offer a number of ways to be tax-efficient with your assets and financial planning. Gifts may allow for immediate tax deductions, a reduction of capital gains taxes when applicable, and ways for beneficiaries like heirs and non-profits to make the most of the gifts received. By planning your charitable giving, you can make your dollars go further than by simply writing a check. It's called good stewardship! Talk with a trusted advisor. We can help.

## Some of the Easiest Ways to Make an Impact

#### **Bequests**

A bequest is the most common way of leaving a legacy. A bequest is a gift of cash, securities or other property designated via an estate plan.

- Make a bequest to Ephrata Community Health Foundation in your will or trust (a specific dollar amount or asset, a percentage of your estate, or a gift of the balance of your estate);
- Leave all or part of your retirement assets to Ephrata Community Health Foundation; or
- Name Ephrata Community Health Foundation as owner or beneficiary of a life insurance policy.

#### **Change of Beneficiary Form**

Filling out a "Change of Beneficiary Form" for a retirement account or life insurance policy is a simple process, not requiring changes to your will or trust. More importantly, retirement plans (IRA, 401k, 403b, pension or other deferred plans) are often the largest assets in your estate – and the most heavily taxed. If you leave these funds to someone other than a spouse, a large portion of these assets might be lost. Simply complete a change of beneficiary form to leave all or a portion of the plan to Ephrata Community Health Foundation. Ephrata Community Health Foundation will receive the full value of these funds.

#### **Gifts from your IRA**

You do not need to delay a gift from your IRA. The now-permanent Charitable IRA Rollover allows you to satisfy your required minimum distribution, substantially reduce taxable income and support Ephrata Community Health Foundation. If you are over age 70½, you can donate up to \$100,000 from your IRA to Ephrata Community Health Foundation, avoiding any federal income tax on these funds. Our office can assist you with language for requesting your fund administrator to effect this donation.

#### **Transfer of Other Assets**

Common bank accounts (i.e., checking, savings and money market accounts) can be transferred to a beneficiary by completing a "**payable on death**" (POD) form. This allows assets to transfer outside the probate process.

A similar method using a "**transfer on death**" (TOD) form is typically used for stocks, bonds, brokerage accounts, mutual funds and real estate.

#### Life Insurance

A gift of life insurance to Ephrata Community Health Foundation is a great way to establish a legacy. There are several options:

- Donate a paid-up policy that you do not need as an immediate gift;
- Change the beneficiary designation of a current policy for a future gift to Ephrata Community Health Foundation; or
- Purchase a new policy and name Ephrata Community Health Foundation as owner and beneficiary.

## We Give to Support Excellence in Care



William Funk started his dental practice in Denver, PA in 1975 because he wanted to be in close proximity to a hospital. Over the years, he established a strong relationship with WellSpan Ephrata Community Hospital, offering patients access to leading-edge equipment and treatments for dental surgery. During this time, Dr. Funk witnessed the hospital grow into a thriving, vital treatment center.

At 72-years-old, he is required by the Federal government to take Required Minimum Distributions from his self-funded retirement plan. Required minimum distributions (RMD) are generally fully taxed by the federal government according to the individual tax rate of a person's total income bracket. The Federal government allows anyone required to draw RMD dollars from their retirement plan to designate RMD money directly to a qualified charity, which reduces the tax effect on that donated money to zero. "Since I have been 70½ years old, I have used this strategy to achieve my philanthropic goals," explains Dr. Funk.

He also knows firsthand the value of having exceptional care available right in the community. In 2012 his mother-in-law had a stroke, requiring surgery and treatment at WellSpan Ephrata Community Hospital. In addition, he and his wife, Holly, have benefited from excellent and timely care over many years.

"If we wish to continue to have local health care of high quality, with a culture of friendliness and compassion, local support must be robust. With so much competition in health care, especially in Lancaster County, we should take nothing for granted!" believes Dr. Funk.

### **Consider Gifting These Assets:**



#### Real Estate

A gift of your appreciated property – such as your home, vacation property, vacant land, farmland or commercial property – may be an ideal way for you to leave a lasting legacy.



#### **Private Business Interests**

Donating appreciated stock or bonds is a common and easy way to benefit our mission. It is also possible to donate all or a portion of privately held business interests. This takes more discussion with and assistance from relevant financial and legal professionals. But yes, it is possible, and can make a wonderful gift!



#### **Farm Commodities**

Make a gift of what you grow and harvest, from farm crops like grain to animal products like dairy, honey and more. You can deduct the cost of production from your taxes and you may qualify for other tax benefits as well. What a creative opportunity.

## **Charitable Gift Annuities**



A Charitable Gift Annuity offers you steady payments for life with funds eventually going to Ephrata Community Health Foundation. This can add an extra measure of financial security in your retirement.

You can use a range of assets (cash, stocks, bonds, commodities, retirement assets and more). You may be able to deduct a significant part of your gift immediately and part of the annuity payments you receive may be tax-free.
